CALL FOR CONFERENCE PRESENTATIONS

The Colorado Chapter of the American Public Works Association (APWA) is requesting abstracts for presentation at the 5th Annual Chapter Conference to be held October 29 & 30, 2018. Presentations are typically 50 minutes in length, although there are opportunities for shorter presentations or workshops. You are invited to speak and share your public works experiences.

The theme for the 2018 Conference is THE NEW AGE OF PUBLIC WORKS

Unlike the “New Age” spiritual movement which draws from esoteric, mysterious and obscure traditions from the past, the “New Age” of Public Works is a more forward looking movement. THE NEW AGE OF PUBLIC WORKS is characterized by alternative approaches to age old problems in a holistic and environmentally sound manner. In THE NEW AGE OF PUBLIC WORKS we must view all infrastructure projects as interconnected, mutually dependent systems. For Public Works to be successful in this “New Age”, planning for the future is vital. To effectively plan for the future we need to be mindful of both the small and big picture issues. April 16, 2018

Current information on the conference will be posted on the conference page at www.colorado.apwa.net as it becomes available. We anticipate notifying speakers of their selection by May 1, 2018.

Abstract format:

- TITLE, by AUTHOR, ORGANIZATION
- Times New Roman font, 12 point,
- Full-justified, single-spaced with 1-inch margins.
- Please limit to one page.
- Include address, phone number and email address for the primary point of contact.

Also include a **brief summary of the abstract** (maximum 5 sentences) and **three (3) learning objectives** for inclusion in the conference program.

Please let us know which Track you recommend for your presentation:

- Organizational
- Operational
- Project Performance
- General Interest

Finally, the committee is considering some format changes to the sessions and presentations for our 2018 conference, focusing on allowing some varying lengths for presentations. Please let us know if you feel your presentation would best fall into one of the following four categories:

Large Presentations

Large presentations provide speakers the opportunity to present original work related to conference topics.

- Large presentations will have 50-minute time slots; and should be overarching in theme.

Small Presentations

Small presentations provide speakers the opportunity to present original work related to conference topics.

- Small presentations for either 3 to 10-minute time slots or 15 to 20-minute time slots. The conference organizers will group oral presentations by theme into sessions that will include three individual presentations and time for questions from the audience.

Panel Presentations

Panel presentations provide speakers the option to organize a panel comprising three related presentations themselves.

- Panel presentation sessions will typically be 50 minutes long, with 30 minutes for presentations and 20 minutes for discussion.
- A panel abstract must include a part summarizing the overall theme of the panel. Submissions should also include individual abstracts for each presentation included in the panel. Panel presentations that seek to bring together experts for interactive discussion should describe questions that will be addressed by the panel, and underlying issues to be discussed, and should provide short bios for each of the panelists.

Lightning Round Presentations

Lightning round presentations provide speakers the opportunity to share their work in brief oral presentations.

- Each presentation is limited to 10 minutes and followed by a five-minute question and answer period.
